You Asked for It: Beyond Awesome Coconut Cake

Last issue, one of our neighbors asked for a good coconut cake recipe, and **Gary** Whitney of Mid Lane answered the call with his wonderful recipe, below:

Cake:

18 $\frac{1}{2}$ oz. box of white cake mix (Duncan Hines Classic White)

1/4 teaspoon of baking powder

1 cup sour cream

1/4 cup flavorless vegetable oil (Mazola Corn Oil)

3 large eggs

¹/₂ of a 15 ounce can of cream of coconut (Goya Brand)

Making the cake:

Preheat oven to 350 degrees.

Thoroughly shake & mix cream of coconut, divide contents of can into 2 halves.

Mix all the cake ingredients, including just half of the cream of coconut.

Beat on high for 2 minutes. While beating, spray butter flavored Pam into two 8" round cake pans.

Pour equal amounts of batter into the two cake pans.

Gently tap on counter to remove any air bubbles.

Bake for 30 minutes, or until toothpick comes out clean. Remove from oven, place cooling rack on top, invert and lift off pan while still hot.

Slowly pour the remaining half of cream of coconut over the top of both layers, spreading over entire top surface while still warm. Repeatedly stab with toothpick to help cake absorb the cream. Let cake cool completely.

Icing:

1 16 oz. box powdered sugar (4 cups)

1 8 oz. package of cream cheese

1 teaspoon coconut extract

1 cup flaked coconut (or more)

<u>Making the icing</u>: Beat powdered sugar, extract, and cream cheese until smooth. Place bottom layer upside down on decorative cake stand or plate. Spread icing on top of bottom layer. Gently place the top layer right side up. Spread remaining icing on top and sides, and sprinkle coconut on top and sides of iced cake.

Editor's Note: I made Gary's recipe but didn't have 8" cake pans so I used 9" pans, and that worked fine for the cake. But one recipe of icing was not nearly enough to cover the larger cake. Instead, I needed to double the icing recipe. I used about ³/₄ of one recipe (into which I mixed some flaked coconut) to ice between the layers. I then made a second recipe, added it to the remainder of the first batch of icing, and had just enough for a nice, not terribly thick, coat of icing over the top and sides of the cake. I also found the icing was a bit too thick, so I added heavy whipping cream while mixing it. And I added vanilla extract. Altogether, I used 2 packages of cream cheese, 2 boxes of powdered sugar, about ¹/₂ cup of whipping cream, and more than 2 1/2 cups of flaked coconut.

Here's the cake I made \rightarrow It was *dee-e-e-licious*! Thank you, Gary!

Houston's Mayoral Runoff ElectionPage 3How We Voted and How We Didn'tPage 3

If you believe your vote is insignificant, December's mayoral runoff election must have come as quite a shock to you. Up until the last minute, nobody knew who had won. When the dust settled, the **winner was Sylvester Turner, who, in a city with over a million registered voters, won by only 3,990 votes.** The press **attributed his victory to Fort Bend County, where,** according to the office of Harris County Clerk, Stan Stanart, **the number of registered voters qualified to vote for Houston's mayor is about two per cent of the number of registered voters in Harris County**. This squeaker election prompts the question: how many of *us* voted?

We live in Precinct Four, but we vote in Election Day Precinct 178. Its boundaries are Westheimer Road to the north, the railroad tracks to the east, Highway 59 to the south, and Highway 610 to the west. Our precinct is mostly made up of West Lane Place and Afton Oaks, with a few extra bits around the edges. According to Harris County records, there are 1,759 registered voters in Precinct 178. Of that number, current records show 694 people voted in the runoff election (568 for King, 125 for Turner, and 1 voter skipped over that part of the ballot.) Less than half, not quite 40% of the registered voters in our precinct cast a ballot.

Our neighborhood made a respectable showing, but about twenty precincts in Harris County had a higher percentage of voter turnout than we did. According to the Unofficial Results published by Stanart's office, three Harris County precincts, each with between three and 15 registered voters, had more than 100% turnout, an apparent impossibility that is not explained. Among precincts in Harris County with significant numbers of registered voters, the highest percentage of turnout was Precinct 365, where 48.8% of its 1,299 registered voters cast ballots. Precinct 365 is north of 610, between Pinemont and Tidwell, Ella and Shepherd Drive.

Next election. In early March, the Harris County Clerk's website at **harrisvotes.com** will post our official polling location for the **March 16 Primary Elections**. In the last election, we voted in an office building on our side of 610 between San Felipe and Westheimer, and nothing indicates there will be a change. If you can't get over there on Election Day, **you can vote early, or you may qualify to vote by mail.** *Or, you might ask a neighbor to take you with them when they vote*. Who knows, by asking them, maybe you'll influence them to vote, too.

Note: The statistics quoted and relied upon in this article came from the **Unofficial Results** chart published on **harrisvotes.com**, and from information received from Dohar in Stan Stanart's office.

Several years ago, our neighbor and former WLPCA board member, **Margaret Ann Bromberger** of Mid Lane, persuaded **Trees for Houston** to donate trees for the **esplanade between Mid Lane and the shops on Richmond Avenue.** Several volunteers from West Lane Place planted about a dozen saplings and watered them during a scorching summer until they were strong enough to survive on their own.

After those saplings grew and needed more care, the WLPCA Board approved an expenditure to feed and trim them. But, when we approached **Jack Swayze**, **District Manager** of **Davey Tree Experts**, he declined our business. Instead, he **volunteered to feed the trees at company expense**. He also examined them, and determined it was too soon to start trimming them.

If you notice a tree getting bigger before your very eyes while you wait for the train to cross Richmond, it will be thanks to the care and community service of Jack Swayze and the experts at Davey Tree.

Weekly household trash pick-up each Monday. NOTE: Recycling is every other Monday, on highlighted days in boxes. Please have your bins out on the curb by 7 am and in by 10 pm.

"Tree Waste" is defined as "clean wood waste such as tree limbs, branches, and stumps (lumber, furniture, and treated wood will NOT be accepted.)" *

"Junk Waste" is defined as "items such as furniture, appliances, and other bulky material." *

* Junk and tree waste may be left on the curb a day or two prior to collection day.

Street Lights. If you notice a street light is not working, please report it to CenterPoint for repair. It only requires a little time and minimal effort to do so.

First, make a note of the identification number on the pole. You will find it a few feet above street level, in a vertical configuration, as pictured, below. Also note the street address.

Then, visit the WLP website, www.wlpca.org, where you will find a link on the home page, "Report Light Outage" that will take you to the page on the CenterPoint website where you report the street light. From there, the process is self-explanatory. You will be asked for your name, address, and phone number. Then, you'll be asked for the **pole number and its address.** It's that simple.
