# The New and Improved 2021 WLPCA Membership Directory by Darryl Shields, West Lane

This year, while we are prevented from getting together in person as we normally would do, the WLPCA board realized it is more important than ever to stay in contact with our neighbors in other ways. To that end, we decided to expand the information we will publish in our next membership directory.

Starting with the 2021 issue, each paying member will have the option to have her or his name listed in the directory individually, along with the telephone number she or he prefers. In the past, we have printed only one listing per household despite the number of paid members who live there. We now will offer a separate listing for any member, that is, anyone who has paid the annual membership fee. If two people live in a household and pay for two annual memberships (\$15 or \$25 each,) each name can be listed on a separate line. If two people live in a household but pay only one membership fee, there will be one listing for the household. Of course, separate listings are elective. In other words, the individual listing is not mandatory, two members can continue to be listed together in harmony!

Is the listed number a cell phone or a landline? Recognizing that many people have eliminated their landlines, and that people like to send text messages, the WLPCA board made the decision to offer a notation in the directory to indicate if the published number is a mobile phone. Again, this information is completely voluntary. If a member prefers not to receive text messages, then she or he should simply decline to indicate that their number is a cell phone.

**Email address?** We are happy to include the email address of any member who elects to include it.

Is the member new to West Lane Place? To identify new neighbors, and identify long-time residents who know the area well, we will include a note in the next directory indicating the year the member moved to West Lane Place. If you want to keep this information secret, don't tell us when you moved here.

I am currently sending emails and calling each member in our records to confirm that our information is accurate, and find out how you wish to be listed. Don't be surprised when you see me in your In Box or on your caller ID!

"Didn't we send our information with our ballots in May?"

Yes, you did. Unfortunately, the WLPCA board had not yet made the decision to expand the listings in the directory when we sent you that form, that's why we didn't ask for the additional information then. Please forgive us for asking you to submit it again. We want the new directories to be better than ever, and we don't want to leave you out! ... WLPCA

## Message on a Bottle: WLPCA and NNO



Since we could not meet with police officers this year at **National Night Out**, the WLPCA board voted to express our solidarity with a **message on a bottle**. The images you see above appear on 1,728 custom printed bottles of spring water we sent to the Central Division of the Houston Police Department. Our HPD liaison, **Mike Weingart**, West Lane, informed us during the summer that many of our officers were dehydrated from the intense heat and needed water. We decided a message of support might be as important to them in this time of upheaval as a drink of water, so we contacted **Talking H2O**, a company in Dallas, who gave us a police discount and rushed to have our bottles delivered to HPD in time for the traditional date of NNO, October 6.

The front of the label is printed with a red heart and a thin blue line below. The back of the bottle shows our neighborhood, and where we are located compared to Nielsen's, a favorite HPD stop.

In addition to water, WLPCA is sending **"Blue Bucks"** coupons to the sixty-three officers that patrol our area on the day shift. The officers can present their coupons to Nielsen's Deli, on Richmond, for any sandwich they like. We learned that Nielsen's has a program for HPD officers to buy menu items for \$5. We partnered with Nielsen's to cover that cost so our officers will know how much we appreciate they are here, and in hopes they will visit West Lane Place often on their way to Nielsen's.

We are looking for similar programs to thank our officers on the evening and night shifts.

## West Lane Place, a Brief History

Today, West Lane Place is a tight collection of upscale urban homes located in the middle of one of the busiest retail and business centers of Houston, but that's not how it started. As World War II was ending in Europe, four developers--Jess Little, L.C. Ferguson, Harry E. Cagle, and H.S. Proctor--received approval to develop a 22-acre tract located south of Westheimer and west of the Union Pacific railroad tracks, to be known as "West Lane Place." The original 1945 plat included 38 lots of approximately one-half acre each. They subdivided some of the lots and built 45 one story, wood siding "starter homes," selling for \$10,000-\$15,000, to meet the demand for housing for the returning soldiers and sailors. At that time, the Houston city limits, as well as Richmond Avenue, ended at the Union Pacific railroad tracks. Westheimer Road was unpaved with ditches on either side and ended at Post Oak Lane. Loop City bus service ended at River Oaks Boulevard. Highland Village Shopping Center, one of the first suburban shopping centers in the country, had just been developed and contained a drug store, hardware store and a Weiners department store. Everything west of West Lane Place was prairie.

"West Lane" and "Mid Lane" were originally short deadend streets north of Westheimer. They were built as part of a 1930's residential development, the Hearle Home Addition, that contained 40 small houses. Before West Lane Place, it was the only development west of the railroad tracks.

The original streets in West Lane Place were dirt or shell and open ditches sufficed for drainage. Flooding was common and wildlife abundant. There were few native trees. Most of the beautiful trees we see today were planted by homeowners. Original residents recount that West Lane Place was considered "out in the boonies" or "halfway to San Antonio" by friends who lived closer to downtown. There are several fascinating personal accounts of the "Leave It to Beaver" lifestyle of West Lane Place in the 1950's on the civic association website, wlpca.org.

In 1947, Jess Little began construction of homes on the 90 lots in the 24 acre West Lane Annex, stretching between West Alabama and the south end of Hackberry Lane. Lana Lane was named for Jess Little's daughter and Hackberry for a tree that grew abundantly in the area. In 1949, West Lane Place Section Three was established with 47 lots. Bash Street was named for a respected Black worker who was involved in the construction of many of the houses in West Lane Place.

In the early 1950's, the City of Houston annexed a large area of land that included West Lane Place. The original sewage treatment plant on Bash at Richmond was replaced with city services, the streets were paved, and the dirt drainage ditch along the west side of the railroad tracks built, which ended flooding. Residents chipped in to build the curbs and gutters for West Lane and West Lane Annex. Residents on Bash didn't participate in that project, and that is why the street levels are different today. Bash, or West Lane Place Section Three, is also different from the other two in that the deed restrictions do not allow the subdivision of the original lots, maintaining the single residence nature of the street.

Unlike Afton Oaks, which was developed in 1953 as one subdivision, each of the three subdivisions in West Lane Place has its own unique plats, deed restrictions, and deed restriction enforcement committees. By 1975, residents revised the deed restrictions for the original West Lane Place (between Westheimer and West Alabama) to allow developers to subdivide the original lots, build multi storied homes, town homes, and condominiums. In 1984, the owners in West Lane Place Annex, (Lana, Hackberry, and the portion of Mid Lane between them) revised their deed restrictions, allowing developers to subdivide lots to permit more than one house on a lot. Bash Place still does not allow subdivided lots. This mishmash of restrictions limits our ability to form contracts with third parties, such as private security, or assess fees for neighborhood projects, but at this point, even if we could all agree to one set of restrictions, the legal costs to accomplish that unity would be staggering.

Originally, there were approximately 175 lots within the three subdivisions. As of 2015, there were 350 lots, and today there are even more. In addition to subdivision deed restrictions, there are many gated communities that have their own restrictive covenants, which complicates matters further.

Only a very few original or early residents of West Lane Place still live here. The original residents formed close relationships because their children played together, and they shared family and home-oriented suburban lifestyles. One early resident who has lived in the neighborhood for 65 years, recalls taking his children, then his grandchildren, and finally some of his ten great grandchildren for walks in the neighborhood.

West Lane Place in 2020 is a vibrant, sophisticated urban neighborhood that continues to see beautiful new homes in the higher price range being built all the time, attracting a wide range of interesting and diverse residents from other parts of town and other parts of the world.
